

Q2 What means do you use to submit locate requests to your local 811 center in advance of all excavation activities you undertake? (mark all that apply)

Q3 Do you "white line" the area you would like located in advance of submitting a locate request?







Q5 Are you familiar with the operations and members of the 811 centers in areas where you perform excavation activities?




